> **Treasurer – December Financials:**

> **Director's Report:**

- The change in hours took effect but did not impact any of the numbers. The additional hours on Saturday appear to be popular.
- There is a full slate of adult programs scheduled (see Directors Report). There is concern that the community room renovation could impact future events.
- Tyler Arboretum will be doing an edible garden on the terrace which will consist of two ten foot long raised beds. Planting will take place in March. It will be advertised in Tyler's newsletter.
- The annual report is due March 2<sup>nd</sup>.
- Janice Stubbs from DCLS would like to come to our March meeting.

    - Arlene will provide copies of the letter to Kathy and Erica for feedback.
    - An appeal letter will be sent to Edgemont residents as well as part of the spring campaign.
