Expenses in April exceeded revenues by over \$17,000, although on a year to date basis, revenues have exceeded expenses by more than \$13,000.

#### Revenues

The April shortfall was attributable primarily to the lack of government funding during the month. Government contributions are budgeted at a roughly \$20,000 per month rate, but are actually received periodically, with nothing received in many months.

Another major variance is the shortfall in donation income. This is budgeted at \$3,500 per month, but actually is dependent on the timing of fundraising efforts. At the end of April, donations were roughly \$4,900 behind budget, but roughly \$5,700 ahead of last year.

Minor income items (interest, fines and lost books) as a group are also behind budget for the year.

#### **Expenses**

Staff expense of just over \$16,000 continued to under run the budgeted monthly rate of \$17,750 in April, resulting in expense favorable to budget of over \$8,500 on a year to date basis. The gain to date is based on an unfilled position.

We continue to under run budget in most other expense items, with the exception of collection expense, which is nearly \$2,100 ahead of its annualized rate through April. However, as indicated in earlier reports, the overrun is a timing difference, which should work itself out over the course of the year. In fact, for April, collection expense was just slightly over \$600.

#### **Balance Sheet**

Our bank balances remain strong, with nearly \$188,000 in current assets as of April 30. We continue to earn minimal interest of 0.25% on the savings account and two of the three trust accounts. When I called the bank today to find out what happened to my request for interest on the other trust account and the checking account, I learned that nothing had been done. Our contact, Anthony Stadler is no longer with BB&T, and his supervisor told me that we cannot get interest on checking, but that he would look into what could be done on the other account.

#### Miscellaneous

There are a couple of other items I wish to mention, but I'll put them in a separate memo. Sorry I cannot be at this month's meeting, but I planned my schedule to be available for a meeting this week.
