Monthly Income and Expenses

With the final installment of Newtown Township funding, revenues exceeded expenses by about \$22,500. Noteworthy this month were

- -the Township's payment made up for the small shortfall in the previous quarterly payment and Township funding is exactly on budget for the year.
- -employee expense, after a bump up in October, is back on track.
- -collection expense of nearly \$5,800 is significantly increased, but is consistent with the budget transfer we approved in October.
- -user fees of \$21 seem to represent the new norm, considering that we stopped charging for DVD rentals some months ago.

Budget

Revenues for the year are about \$6,600 under budget. The major variances are fundraising (about \$3,000) and user fees (about \$2,600) below budget. We still might achieve our fundraising goal for the year if the impact of the second fundraising solicitation is felt soon enough. User fees, however, are a lost cause.

Expenses year to date are about \$10,500 below budget, resulting in net revenues of nearly \$16,000 year to date. Major contributors are shortfalls in staff expense, fundraising expense, and collection expense. However, with no further Township funding for December and the additional collection expense previously authorized, whether the Library breaks even for the year depends pretty much on the timing of revenues from the second fundraising.

Balance Sheet

With the net revenue in November, total equity rebounded to nearly \$196,800. Almost all of the assets are in bank accounts. Cash of about \$34,700 in checking, together with any additional funds from fundraising, must carry us through until the Township's next funding in February. Or, we might have to dip into Savings.

One curious item, which perhaps somebody can explain, is the existence of a small capitalized equipment asset (\$78). The Library has considerable assets that do not appear on this financial balance sheet (eg. books). Why this one item?

Fundraising

Total fundraising at November 30 was about \$6,000 ahead of last year. This was almost entirely due to the carryover effect into January of last year's second fundraising.

Other

The year to date revenue and expense statement, the interest expense statement and the transaction by category statement are also attached for information. There is very little to be said about them that has not already been said.
